3. LEGAL REGULATIONS AND DOCUMENTS ON RESEARCH AND DEVELOPMENT

3.1. THE VALID LEGAL REGULATIONS, WHICH DIRECTLY ADJUST THE AREA OF RESEARCH AND DEVELOPMENT

The area of publicly supported research and development is currently managed by the Act No. 130/2002 Coll. about the support of research and development from public funds, which has been valid since 1 July 2002 and which determines in detail the basic terms, the subject and the ways of support, conditions on that support, the ownership of fixed tangible assets obtained for research and development purposes, public tenders in research and development, the provision of information about research and development, and authorities in the field of research and development. The Act is supplemented with the following three Government Directives:

- Government Directive No. 267/2002 Coll. on the information system in research and development,
- Government Directive No. 461/2002 Coll. on target-oriented support in research and development from public funds and on public tenders in research and development,
- Government Directive No. 462/2002 Coll. on the institutional support of research and development from public funds and on the evaluation of research intentions.

3.2 THE VALID LEGAL REGULATIONS RELATED TO THE AREA OF RESEARCH AND DEVELOPMENT

The area of research and development and its support from public funds, with the exception of the above-described regulations, is indirectly governed also by a number of related legal regulations, which determine, for example, rights of the state for adjusting the competitive environment (Public Support Act), adjusting assignments of public orders, or for the establishment of the position of the Academy of Sciences of the Czech Republic, the position of universities, rules for the information systems used by the state administration, etc. Research and development is also influenced by general legal regulations governing, for example, contractual relations, the industrial legal protection, the provision of information, inspections, etc. They are especially the following regulations:
